BY THE PRESIDING COMMISSIONER: On August 16, 2023, Currituck Water and Sewer, LLC (Currituck) filed an Application for a Certificate of Public Convenience and Necessity and for Approval of Rates to provide water and wastewater utility service to the Carolina Village subdivision (Carolina Village) in Currituck County, North Carolina in accordance with N.C. Gen. Stat. § 62-110. Currituck filed amended and supplemental information on September 20, 2023, and November 14, 2023.

On February 14, 2024, the Commission issued an Order Scheduling Hearings, Establishing Discovery Guidelines, and Requiring Customer Notice, which set this matter for a public witness hearing on Monday, May 20, 2024.

On February 29, 2024, the Commission issued an Order Rescheduling Public Witness Hearing and Revising Dates for Reports and Customer Notice, which rescheduled the public witness hearing for Thursday, May 9, 2024. The Order directed Currituck to consult with the Public Staff to develop a Notice to Customers (Notice) to be delivered to all affected customers. The Notice stated that the Commission may cancel the public witness hearing if no significant protests were received from customers by Thursday, May 2, 2024.

On March 21, 2024, Currituck filed its Certificate of Service verifying that the Notice was mailed to all affected customers.

On May 7, 2024, Currituck and the Public Staff (collectively, the Parties) filed a joint motion to cancel the public witness hearing. In support of the motion, the Parties state that no consumer complaints have been filed in this docket or received by the Public Staff. Therefore, the Parties request that the Commission cancel the public witness hearing.

Based on the foregoing and the record, the Presiding Commissioner finds that the public witness hearing scheduled for Thursday, May 9, 2024, at 7:00 p.m. in the Currituck County Courthouse, 2081 Caratoke Highway, Courtroom A, Currituck, North Carolina, is hereby canceled.

IT IS, THEREFORE, SO ORDERED.
