NOW COMES Western Carolina University, and submits the following statement and proposed order excerpt pursuant to the Commission's May 16, 2022, Order Requiring the Filing of Proposed Orders and Briefs.

- 1. Procedural history relevant to Western Carolina University (WCU).
 - a. On August 13, 2021, the North Carolina Utilities Commission
 (Commission) initiated the above-captioned proceeding with its
 Order Establishing Biennial Proceeding, Requiring Data, and
 Scheduling Public Hearing.
 - b. On December 20, 2021, the Commission issued its Order Granting
 Motion for Extension of Time to Western Carolina University and
 Appalachian State University, d/b/a/ New River Light and Power
 Company.
 - c. On December 21, 2021, counsel for WCU filed the Joint Comments,
 Proposed Rates and Contracts of Western Carolina University and
 New River Light & Power (Joint Comments).

- d. On January 31, 2022, the Affidavit of Publication of Public Notice was filed for WCU.
- e. On February 24, 2022, the Public Staff of the North Carolina Utilities Commission (Public Staff) filed its initial statement. With respect to WCU, that statement said: "The Public Staff does not object to WCU's and NRLP's proposed rates for purposes of the 2021 proceeding."
- f. On February 24, 2022, Appalachian Voices filed its initial comments. Footnote 1 of those comments states: "Appalachian Voices takes no position on WCU's proposal at this time but reserves the right to comment in future proceedings."

2. <u>Issues relevant to the WCU proposed rates and contracts.</u>

There are no disputed issues with the WCU proposed rates and contracts. The Joint Comments state that WCU was changing its wholesale power supplier from Duke Energy Carolinas, Inc., to Carolina Power Partners, LLC (CPP), effective January 1, 2022. WCU explained that the rates it proposed to pay any small power producers and cogenerators that wished to provide electric power back to the WCU distribution system would be based on the actual wholesale cost of power that would be avoided by WCU not buying that power from CPP. The proposed rates and contracts are buy all/sell all arrangements rather than net billing or net metering. No party opposed the WCU proposal.

3. <u>Proposed order wording specific to WCU</u>.

WCU proposes that the Commission's order on the utilities' avoided cost rate proposals in this proceeding include the following wording for WCU. This wording tracks

the Commission's August 13, 2021, Order Establishing Standard Rates and Contract Terms for Qualifying Facilities in Docket No. E-100, Sub 167, because the WCU methodology and proposal is essentially the same (except for change of wholesale power supplier) in the present proceeding as was approved in Docket No. W-100, Sub 167.

FINDING OF FACT NO.

It is appropriate to require WCU to offer all QFs contracting to sell 1 MW or less variable rates based upon their wholesale cost of power and to offer long-term fixed price rates that track CPP's wholesale charges to WCU.

EVIDENCE AND CONCLUSIONS FOR FINDING OF FACT NO.

The evidence supporting these findings of fact is found in the Joint Comments filed by WCU and New River, the comments of the Public Staff, and the entire record herein. In the Joint Comments WCU proposed to pay variable rates based on its wholesale cost of power from CPP. WCU further proposed to offer long-term fixed price rates based on its contract with CPP. The Public Staff did not object to the proposed rates for WCU. No parties filed objections to WCU's proposals. The Commission therefore concludes, based upon the foregoing and the entire record herein, that WCU's proposed rates and contracts should be approved.

4. Conclusion

THEREFORE, Western Carolina University respectfully requests that the Commission approve its filing of December 21, 2021.
