Annual report regarding interconnections with utility-scale solar facilities

Dear Ms. Dunston:

Pursuant to the North Carolina Utilities Commission's February 12, 2024, Order Requiring Annual Reports Regarding Interconnections with Utility-Scale Solar Facilities in this docket, attached please find as Appendix 1 a table listing the operating utility-scale solar facilities interconnected to facilities owned by electric membership corporations ("EMCs") in North Carolina. In compiling this data, North Carolina Electric Membership Corporation ("NCEMC"),1 relied on the statutory definition in N.C.G.S. § 130A-309.240(a)(6) of a "utility-scale solar project" as a "project capable of generating 2 megawatts AC (MW AC) or more directly connected to the local or regional electrical grid with the ability to deliver power to the electrical grid." NCEMC notes that in some cases, the AC nameplate capacity of some projects meets or exceeds 2 MW AC: however, the capability of the facility to generate power in excess of 2 MW AC is limited by inverter controls and/or contractually in power purchase agreements and interconnection agreements. In addition, this report includes only operational projects (i.e., delivering power to the electric grid), and does not include a listing of any projects that are planned or under Lastly, NCEMC notes that this report does not include any utility-scale solar projects located within the service territories of EMCs in North Carolina that directly interconnect to facilities owned by the regulated electric public utilities or the municipal power suppliers for the delivery of power to the electrical grid. It is NCEMC's understanding that these utility-scale projects would be identified through the reports filed by those respective parties.

NCEMC and its members will continue to monitor the status of these projects and file updates annually pursuant to the Commission's February 12, 2024, Order.

¹ For clarity, NCEMC notes that this report includes information on all utility-scale solar projects interconnected to facilities owned by EMCs in North Carolina, including NCEMC's 20 participating and five independent members, as well as French Broad EMC, a member of the North Carolina Association of Electric Cooperatives, Inc.

In addition, pursuant to Commission Rule R1-5, attached please find the verification by Michael Diorio, Distribution Planning Engineer, supporting the listing of operational facilities interconnected to EMC distribution and transmission systems.
