NOW COME Duke Energy Carolinas, LLC and Duke Energy Progress, LLC (collectively “the Companies” or “Duke”), through counsel and in response to the Commission’s April 11, 2017 *Order Requiring Filing of List of Witnesses and Estimated Time for Cross Examination*, which required the Companies to consult with the parties to this proceeding and to file a proposed joint list of witnesses to be called at the evidentiary hearing scheduled to begin April 18, 2017 in this proceeding, the order of witnesses, the order and the estimated time for cross-examination. The Companies have consulted with the parties and respectfully submit the following:

List of Witnesses, Witness Order, and Estimates of Cross-Examination

A. Witness Order and Combination of Direct and Rebuttal Testimony

The Companies have consulted with the parties, and the parties jointly propose to present witnesses in the following order: Duke, Dominion North Carolina Power (“DNCP”), the North Carolina Sustainable Energy Association (“NCSEA”), Southern Alliance for Clean Energy (“SACE”), Cypress Creek Renewables, LLC (“Cypress Creek”), and the Public Staff of the North Carolina Utilities Commission (“Public Staff”). The Companies and DNCP each propose to combine the presentation of their direct and rebuttal testimonies but reserve the right to recall their witnesses at the close of the Public Staff’s case.

The Companies intend to present their witnesses in the following order: (1) Witness Lloyd M. Yates, (2) Witness John Samuel Holeman, II, (3) Witnesses Kendal C. Bowman, Glen S. Snider, and Gary R. Freeman (as a panel). Following Duke's presentation of its case, DNCP intends to present its Witnesses Bruce E. Petrie and J. Scott Gaskill as a panel. Finally, the Public Staff intends to present its three witnesses, John Robert Hinton, Dustin R. Metz, and Jay B. Lucas as a panel as well. Cypress Creek has specifically requested a date certain of April 20, 2017 for its Witness, Patrick McConnell, to present his testimony.

B. Order of Cross-Examination

For cross-examination of the Companies' and DNCP's witnesses, the Companies propose the following: NCSEA, Cypress Creek, SACE, the Attorney General, and the Public Staff. For cross-examination of the intervenors' witnesses, the Companies propose the following: NCSEA, Cypress Creek, SACE, the Attorney General, the Public Staff, Duke, and Dominion. The Carolina Industrial Group for Fair Utility Rates I, II and III and Strata Solar, LLC have indicated that they do not intend to cross-examine witnesses. As of the time of this filing, the Companies have not heard from counsel for intervenors North Carolina Electric Membership Corporation, Carolina Utility Customers Association, North Carolina Pork Council, City of Fayetteville, or O2 Energies, LLC.
