Riverbend Estates Water Systems, Inc. - Transfer to CWSNC

Notice of Closing of Transfer of Water System Assets

Dear Ms. Campbell:

I write on behalf of Carolina Water Service, Inc. of North Carolina ("CWSNC") and Riverbend Estates Water Systems, Inc. ("Riverbend" or "REWS") to state on the record that the transfer of the referenced assets was closed on September 19, 2019 and that Riverbend's former utilities holdings are now owned by CWSNC. Additionally, this letter addresses the actions associated with final closure of this longstanding matter.

After closing, CWSNC timely provided the Riverbend customers with the notice required in the Commission's May 16, 2019 Order Approving Transfer ("Order") and then filed a Certificate of Service of Customer Notice with the North Carolina Utilities Commission on October 4, 2019, within the time prescribed by Order. Upon review of the docket, counsel notes that the Order requires notice of the date that the closing actually occurred and respectfully requests that this be received in compliance with that provision of the Order.

To review and address the remaining actions required to close these dockets, CWSNC requests Commission confirmation that, effective September 19, 2019:

> The Public Staff's recommended fines and penalties against REWS (\$84,000 for alleged abandonment and \$33,000 for charging higher

- rates without Commission approval) are deemed withdrawn, per provision of the Order at Ordering Paragraph 9;
- The Certificate of Public Convenience and Necessity to provide water utility service granted to REWS is cancelled (per Ordering Paragraph 10);
- The Certificate of Public Convenience and Necessity for providing water service is granted to CWSNC and that CWSNC is discharged as the Emergency Operator ("EO"), pursuant to Ordering Paragraphs 2 and 11;
- The Public Staff shall audit the revenues CWSNC received from customers as EO and all expenses and capital expenditures (including due diligence costs) for the Riverbend Estates Water System during the EO period, from May 16, 2017 through September 17, 2019, and shall file—within 90 days of the closing date of the transfer—a report thereon, reconciling the revenues and expenses. "Such analysis and report shall clearly reflect the Commission-approved reduction in rates effective on March 13, 2018 pursuant to the Commission's March 13, 2018 Order in the EO Docket." Order, Ordering Paragraph 12, p. 10.
