JEFFRIES, HEARING EXAMINER: On March 12, 2024, the Commission issued an Order in the above-captioned docket requiring L.W. Wilson Moving & Trucking, LLC (Respondent), to appear before the Commission on April 19, 2024, and show cause, if any, why its certificate of exemption should not be revoked for willful failure to attend a mandatory MRT training seminar as required by Ordering Paragraph No. 5 of the Commission's May 30, 2023 Order Granting Application for Certificate of Exemption, which authorized Respondent to transport household goods between all points and places within North Carolina under Certificate of Exemption No. 3048.

At the call of the matter for hearing, Respondent was neither present nor represented by counsel.

Based upon the entire record in this docket, the Hearing Examiner makes the following

**FINDINGS OF FACT**

1. The Respondent holds Certificate of Exemption No. C-3048 issued by this Commission.

2. Ordering Paragraph No. 5 of the Commission's May 30, 2023 Order Granting Application for Certificate of Exemption, which authorized Respondent to

transport household goods between all point and places within North Carolina, requires “[t]hat the Applicant shall attend an online Maximum Rate Tariff (MRT) training seminar no later than (3) months from the date of this Order.”

3. The Public Staff, on December 7, 2023, notified Commission Staff that Respondent had not attended any of the MRT Training seminars held since its certification on May 30, 2023.

4. On December 14, 2023, Commission Staff sent a certified letter addressed to Lee Wilson, Jr., owner of L.W. Wilson Moving & Trucking, LLC, notifying him that a representative for L.W. Wilson Moving & Trucking, LLC, was required to attend the next scheduled MRT training seminar or the Commission would have no other option but to cancel L.W. Wilson Moving & Trucking, LLC’s certificate of exemption.

5. On February 6, 2024, the Commission issued an Order Suspending Certificate of Exemption for Failure to Attend MRT Seminar. Among other things, the Order required L.W. Wilson Moving & Trucking, LLC, to attend the next MRT training seminar, which was scheduled to be held online on February 29, 2024, to prevent the suspension of its certificate of exemption on March 1, 2024. As an alternative, the Order would require L.W. Wilson Moving & Trucking, LLC’s appearance before the Commission to show cause why its certificate of exemption should not be revoked for failure to comply with the Commission’s Orders.

6. On March 1, 2024, the Public Staff notified Commission Staff that L.W. Wilson Moving & Trucking, LLC, failed to attend the next scheduled MRT training seminar held on February 29, 2024.

7. The Respondent did not appear at the hearing on April 19, 2024, nor did anyone appear on Respondent’s behalf.

## CONCLUSIONS

Commission Order Granting Application for Certificate of Exemption requires that all Commission-certified North Carolina household goods movers attend a MRT Seminar whether in person or online within 3 months of the issuance of their Certificate of Exemption. Respondent has not complied with this requirement, in spite of Commission Staff’s repeated notifications to Respondent of its obligation to attend an online MRT training seminar or risk suspension and revocation of its certificate.

IT IS, THEREFORE, ORDERED as follows:

1. That Certificate of Exemption No. C-3048, heretofore issued to L.W. Wilson Moving & Trucking, LLC, be, and the same is hereby, revoked and canceled; and

2. That a copy of this Order shall be sent to Respondent by Certified Mail, Return Receipt Requested.
