Last month the residents of Silverton received notification that Pace Utilities would possibly be acquired by Carolina Water Service, resulting in a significant rate increase. **We strongly oppose this acquisition.**

We, as residents of Silverton Subdivision, have been having issues with the low water pressure, poor drinking water quality, and colored water for years. If the application is approved, our water rates will more than double. These increases are outlandish considering the poor water services. In addition, our new monthly rates would be 2 and 3 times the water rates in nearby counties. We consider this unacceptable.
