Pursuant to decretal paragraph 8 of the Order Scheduling Hearing and Establishing Procedures issued in this proceeding on June 17, 2022, I am transmitting for filing in the above-referenced proceeding on behalf of the Village of Bald Head Island a proposed order of witnesses, estimated cross-examination times, and the proposed order of cross-examination.

As directed by the Commission in its procedural order, counsel has consulted with counsel for Bald Head Island Transportation, Inc. ("BHIT"), Bald Head Island Limited, LLC ("Limited"), Bald Head Island Club, Inc. ("Club"), Bald Head Association ("Association"), SharpVue Capital, LLC ("SharpVue"), and the Public Staff in the preparation of the attached and has attempted to reconcile insofar as possible the parties' competing proposals.

Counsel is advised that the Association and the Public Staff do not intend to cross-examine witnesses at the hearing.
