NOW COMES Currituck Water and Sewer, LLC and submits this Certificate of Service.

On November 14, 2023 Currituck Water and Sewer LLC filed with the Commission through electronic filing in the Clerk's Office a Second Amended Application in response to a deficiency notification from the Public Staff. The Company failed to serve this Second Amended Application on the Public Staff. By e-mail dated November 27, 2023 the Public Staff informed the Company that the Second Amended Application and filing in response to the Public Staff deficiency letter were not served on the Public Staff and the Public Staff was unaware of it. The Public Staff indicated that it would review the filing, but that the time limit for review will run from the time and receive service.

On December 1, 2023 the Public Staff submitted a letter to the Commission indicating that the Second Amended Application was incomplete. On December 5, 2023 the Commission issued an order requiring that the Applicant shall serve upon the Public Staff the Amended Application and confidential exhibit and address any deficiencies noted by the Public Staff. On December 5, 2023 a representative on behalf of the Company provided the Public Staff a copy of the second Amended Application. On December 6, 2023 the Public Staff communicated with the Company raising several questions with respect to the process the Company had followed in attempting to serve the Second Amended Application on the Public Staff and to comply with the Commission's order of December 5, 2023. On December 11, 2023 the Company responded to the Public Staff's questions. On December 11, 2023 the Public Staff through e-mail indicated

that proper service requires provision of the confidential materials filed on November 14, 2023. The Public Staff said that it did not see where those were provided. The Public Staff indicated that once the Public Staff receives those, the Public Staff will begin processing the amended application.

In light of the foregoing I hereby certify that a copy of the Second Amended Application was served on the Public Staff on December 5, 2023. I also hereby certify that the confidential portions of the Second Amended Application consisting of Currituck Water and Sewer, LLC and Currituck Water and Sewer Holding, LLC Balance Sheet dated September 31, 2023 and Currituck Water and Sewer, LLC and Currituck Water and Sewer Holding, LLC Statement of Operations for the Period January 1, 2023 to September 31, 2023 was duly served upon the Public Staff by depositing same in a depository of the United States Postal Service, first class postage prepaid, or by electronic delivery.
