Re: Docket Nos. W-1259, Sub 5 and W-1328, Sub 6 – Application for Transfer of Public Utility Franchise from Meadowlands Development to Red Bird Water and for Approval of Rates

## Dear Ms. Dunston:

Meadowlands Development, LLC (Meadowlands), and Red Bird Utility Operating Company, LLC d/b/a Red Bird Water (Red Bird Water), filed an application seeking to transfer Meadowlands' Certificate of Public Convenience and Necessity to provide sewer utility service to Red Bird Water in the above-referenced docket on October 9, 2020. Meadowlands and Red Bird filed updates, amendments, or otherwise supplemented their application on October 21, 2020, July 12, 2021, August 2, 2021, December 7, 2022, and June 15, 2023.

The Public Staff has reviewed the filings and deems the application incomplete for the reasons set forth below.

- 1. The financial information provided in the sections of the Application Form listed below is too outdated for the Public Staff to make a recommendation. The Public Staff needs information current as of no earlier than December 31, 2022, to move forward with its investigation.
  - a. Revenues and Expenses (page 4 of Application Form)
  - b. Original Cost of Utility System (page 5 of Application Form)
- 2. The financial information required in the section of the Application Form listed below was not provided or is outdated. The Public Staff needs this information

current as of no earlier than December 31, 2022, to move forward with its investigation.

- a. Other Financial Information Item 1 (page 6 of Application Form).
- b. Items 1 and 2 reference Attachments G and L for this information. However, Attachments G and L to the Company's application do not provide the required capital structure information for the Company.
- 3. The addendum showing the projected cash flows and income statement for the utility system for the first five years of operation required by Item 3 on page 7 of the Application Form was not provided. The Public Staff needs a completed addendum for the five-year period beginning on January 1, 2023, to move forward with its investigation.
- 4. The documents an applicant may submit in lieu of a completed addendum were either (1) not provided, as is the case with Items 3(1)<sup>1</sup> and 3(3), or (2) contain financial information that is too outdated for the Public Staff to make a recommendation, as is the case with Item 3(2). If the Company intends to provide these documents in lieu of submitting a completed addendum, the Public Staff needs information current as of no earlier than December 31, 2022, to move forward with its investigation.
- 5. The financial information provided to satisfy the requirements of Item 7 of the Application Form Exhibits list (the most recent fiscal year financial statements for Red Bird Utility Operating Company, LLC as the Purchaser) was not provided. The Public Staff needs financial statements for Red Bird Utility Operating Company, LLC on a stand-alone basis for the period ending on December 31, 2022, to move forward with its investigation.
- 6. The financial information provided to satisfy the requirements of Item 8 of the Application Form Exhibits list (the most recent fiscal year financial statements for CSWR, LLC as the Purchaser's parent company) was not provided. <sup>2</sup> The Public Staff needs financial statements for CSWR, LLC the period ending on December 31, 2022, to move forward with its investigation.

7. Exhibit 4 on the Application Form Exhibits list requires a copy of exhibits showing that the Seller has ownership of all property necessary to operate the utility. This information was not provided.

Based on the foregoing, the Public Staff respectfully recommends that the Commission determine that the items enumerated above are deficiencies and render the application incomplete. If the Commission does not consider any of the items listed above a deficiency, the Public Staff respectfully requests that the Commission issue an order directing the Company to file the information enumerated above in the docket and provide the Public Staff a copy within 10 calendar days.
