BY THE CHAIRMAN: On August 6, 2014, in Docket No. SP-3475, Sub 0, the Commission issued an Order granting Innovative Solar 34, LLC (Innovative Solar) a certificate of public convenience and necessity (CPCN) for construction of a 50-MW solar photovoltaic electric generating facility to be located at the intersection of Currie Road and Derby Road in Jackson Springs, Richmond County, North Carolina, and accepted registration of the facility as a new renewable energy facility.

On January 23, 2015, in Docket Nos. SP-3475, Sub 0 and SP-5189, Sub 0, Innovative Solar and Eden Solar, LLC (Applicant) filed an amended CPCN application with the Commission requesting that the CPCN and registration statement be transferred to the Applicant. Innovative Solar and the Applicant further requested that the capacity of the facility be changed to 47.7 MW; that the contact information for the Applicant be changed to the address of FLS Energy, Inc., 130 Roberts Street, Asheville, North Carolina 28801; and that the address of the facility be updated to state the address as 2252 Derby Road, Ellerbe, North Carolina.

Based upon the foregoing and the record, the Chairman finds good cause to transfer the CPCN and registration statement to the Applicant, make the additional changes in information requested by the Applicant, cancel the CPCN issued to Innovative Solar, and close Docket No. SP-3475, Sub 0. Further, Appendix A hereto shall constitute the amended CPCN issued to the Applicant.


IT IS, THEREFORE, ORDERED as follows:

1. That the amended application filed by Innovative Solar 34, LLC, and Eden Solar, LLC, to transfer the certificate of public convenience and necessity and registration for a 47.7-MW photovoltaic electric generating facility to be located at 2252 Derby Road, Ellerbe, Richmond County, North Carolina, to Eden Solar, LLC, shall be, and is hereby, approved.
2. That Appendix A shall constitute the amended certificate of public convenience and necessity reflecting the transfer of the certificate to Eden Solar, LLC, and the additional changes requested.
3. That Eden Solar, LLC, shall annually file the information required by Commission Rule R8-66 on or before April 1.
4. That the certificate of public convenience and necessity and registration issued to Innovative Solar 34, LLC, in Docket No. SP-3475, Sub 0 for this solar photovoltaic facility shall be, and are hereby, cancelled.
5. That the Chief Clerk shall close Docket No. SP-3475, Sub 0.


