Dear Ms. Jarvis:

On July 8, 2015, the North Carolina Utilities Commission (the "Commission") issued an order granting a Certificate of Public Convenience and Necessity ("CPCN") to Johannes Gutenberg Solar, LLC ("Gutenberg Solar") for construction of a solar facility to be located east and west of Cornwallis Road (SR-1301) within an approximately 1.5 mile radius of the intersection of Cornwallis Road and NC Highway 186 in an unincorporated area of Garysburg Township Extra Territorial Jurisdiction, Northampton County, North Carolina. Gutenberg Solar is hereby requesting an amended CPCN to include additional parcels of land and to reflect changes in ownership, equipment, capacity, projected sales, and operation date. An updated FERC Form 556, Conditional Use Permit and Application for a New Renewable Energy Facility will be submitted in the near future.

In support of this amendment, Gutenberg Solar is providing the following updates to its application filed on March 30, 2015, as amended June 8, 2015:

The Facility has increased from a 74.9 MW AC photovoltaic (PV) array to a 79.9 MW AC PV array.

- 6. Exhibit 3(i)

The facility will generate 79.9 MW electricity. The source of power is solar.

7. Exhibit 3(ii)





The facility will consist of approximately three hundred and seventy thousand (370,000) 330 to 455 W photovoltaic (PV) modules affixed to single-axis tracking system and ground-mounted racks. The system will utilize thirty-two (32) 2.5 MW inverters.

8. Exhibit 3(iii)

The facility's nameplate capacity is 79.9 MW. The gross capacity is 79.9 MW and net projected maximum capacity is 79.9 MW. With full solar resources, the dependable capacity is 79.9 MW. The dependable capacity will be reduced when the solar resources are diminished.

9. Exhibit 3(iv)

The Facility is projected to come on line by December 31, 2019.

10. Exhibit 3(ix)

The projected year one annual sales of the facility is approximately 190,000,000 kWh/yr.

11. Exhibit 6(i)(a) should be amended to read as follows:

EDF Renewable Development, Inc. ("EDF") recently acquired Gutenberg Solar from Geenex Solar, LLC ("Geenex"). EDF's roots in the United States began thirty years ago as an operations and maintenance company. It is currently the largest provider of third-party operations and maintenance services in North America, maintaining wind, solar, biomass, biogas, and energy storage projects across the continent.

Doug Copeland, Regional Project Development Manager for EDF Renewable Energy, Inc., an affiliate of EDF, has worked in the renewable energy industry for over ten years, including nine years on projects in PJM. Mr. Copeland has worked on renewable energy projects in fifteen different states, including the Pecan Solar, LLC solar facility in Northampton County. Prior to working in renewable energy, he ran a nationally recognized economic development program in St. Paul, Minnesota, working with small business owners, local government bodies, and outside investors. He has a master's degree from Boston College and a bachelor's degree from Villanova University.




