4 name is Heather Fennell, Hearing Examiner and Staff
5 Attorney for the North Carolina Utilities Commission.

6 I now call for hearing Docket Number G-9,
7 Sub 791, which is the Application by Piedmont Natural
8 Gas Company, hereinafter called Piedmont, for its
9 Annual Review Proceeding Pursuant to North Carolina
10 General Statute § 62-133.4(c) and Commission Rule
11 R1-17(k) (6).

12 On August 2nd, 2021, Piedmont Natural Gas
13 Company filed testimony of witnesses Todd Breece,
14 Jeffrey Patton, and MaryBeth Tomlinson in the
