BY THE PRESIDING COMMISSIONER: On July 8, 2020, the Commission issued an Order Requiring Filing of Testimony, Establishing Procedural Guidelines, and Requiring Public Notice in the above captioned docket establishing a deadline of July 21, 2020 for Applicant's additional testimony and exhibits, a deadline of August 10, 2020, for the Public Staff's testimony, and a deadline of August 25, 2020, for the Applicant's rebuttal testimony.

On July 21, 2020, Sweetleaf Solar, LLC (Sweetleaf Solar or Applicant) filed a Motion for Extension of Time for the filing of its additional testimony and exhibits. In the motion, the Applicant also seeks an extension of deadlines for the testimony of the Public Staff, and the Applicant's rebuttal testimony. In support of its motion, the Applicant stated that while it has been working diligently to prepare testimony and exhibits, the complexity of the underlying issues related to the PJM interconnection process requires additional time beyond the time provided for in the Order. In addition, Sweetleaf Solar stated that it had contacted Public Staff regarding its request for an extension of time, and that the Public Staff does not object to the request provided that other deadlines for testimony are similarly extended. Sweetleaf Solar requests that the additional testimony and exhibits deadline be extended to August 11, 2020, the Public Staff and Intervenor's testimony and exhibits deadline be extended to August 31, 2020, and Applicant's rebuttal testimony and exhibits be extended to September 15, 2020.

Based on the Sweetleaf Solar's motion and the record, the Presiding Commissioner finds good cause to extend the date filing additional testimony and exhibits

to August 11, 2020, the Public Staff and Intervenors' testimony and exhibits deadline to August 31, 2020, and Applicant's rebuttal testimony and exhibits to September 15, 2020.

IT IS, THEREFORE, SO ORDERED.
