BY THE COMMISSION: On February 18, 2022, BellSouth Telecommunications, LLC d/b/a AT&T North Carolina, and Charter Fiberlink NC-CCO, LLC filed for Commission approval an amendment to their existing interconnection agreement, approved October 28, 2005.

The amendment implements the changes mandated by the Federal Communications Commission (FCC) in WC Docket No. 18-141, by FCC 19-66 and FCC 19-72 (FCC UNE and Resale Forbearance Orders), and WC Docket No. 19-308, by FCC 20-152 (FCC UNE Relief Order).

The filing was made in compliance with the Commission Rule R17-4(d) and Sections 252(e) and 252(i) of the Telecommunications Act of 1996. The Commission considered the matter at its Regular Staff Conference on April 25, 2022. The Public Staff recommended that the amendment be approved, and the Commission approved the recommendation.
