**MOTION FOR EXTENSION OF
TIME TO FILE CROSS
EXAMINATION EXHIBITS AND
REDIRECT EXHIBITS**

The Sierra Club, through counsel, file this motion to extend the time to file testimony in this docket. In support of this motion, the Sierra Club states as follows:

1. On February 23, 2021, Duke Energy Carolinas, LLC (“DEC”) filed its application for approval of its fuel and fuel-related cost recovery rider.
2. Pursuant to the Commission’s March 18, 2021 Order Scheduling Hearing, Requiring Filing of Testimony, Establishing Discovery Guidelines and Requiring Public Notice, the deadline to file intervenor testimony was May 10, 2021 and DEC’s deadline to file rebuttal testimony is May 20, 2021. In addition, the deadline to file a list of potential cross-examination and redirect examination exhibits and provide copies of the exhibits to the other parties and the Commission was scheduled for May 21, 2021.
3. On May 7, 2021, the Sierra Club filed a Motion for and Extension for Time to File Testimony, which the Commission granted on May 11, 2021. The Commission’s order set a new deadline to file intervenor testimony for May 17, 2021 and DEC’s rebuttal testimony for May 27, 2021.
4. In light of the Commission’s order, the Sierra Club respectfully requests an extension of the deadline to file potential cross-examination and redirect exhibits until

May 28, 2021. This revised schedule would allow all parties to identify potential cross and redirect exhibits in light of the revised testimony deadlines.

5. The Sierra Club has reached out to counsel for all other parties to this docket. The Public Staff and the Carolina Utility Customers Association, Inc. have indicated that they do not object to this motion. As of the time of filing this Motion, no party has raised an objection to the request.

WHEREFORE, the Sierra Club prays for an extension of time until May 28, 2021 to submit cross examination and redirect exhibits.
