BY THE CHAIR: On November 19, 2021, the Commission issued an Order Requiring Filing of Carbon Plan and Establishing Procedural Deadlines. The Commission was directed in House Bill 951 (S.L. 2021-165) to develop a Carbon Plan that takes reasonable steps to reduce carbon dioxide emissions in this State from electric generating facilities owned or operated by Duke Energy Progress, LLC (DEP), and Duke Energy Carolinas, LLC (DEC, together with DEP, Duke).

As part of the Carbon Plan development process, the Commission directed Duke to hold a minimum of three stakeholder meetings. The Commission also directed Duke and the Public Staff to file reports on these stakeholder meetings to keep the Commission apprised of the work of the stakeholders. On January 12, 2022, Duke filed a letter stating that the first stakeholder meeting will be held virtually on January 25, 2022.

To further the goal of keeping the Commission apprised of the sufficiency of the stakeholder process, Duke and the Public Staff are directed to update the Commission on the January 25, 2022 stakeholder meeting on Monday, February 7, 2022, directly following the Commission's regularly scheduled Staff Conference. If no Staff Conference is held that day, the update will begin at 10 a.m. Updates on the stakeholder meetings to be held in February and March will be scheduled by subsequent order of the Commission.

Additional stakeholder intervenors in this docket may file a request with the Commission to present a brief update. The update presented by Duke may not exceed ten minutes and each overview presented by the Public Staff and stakeholder intervenors may not exceed five minutes. The limited purpose of the updates is to inform the Commission of the sufficiency of the stakeholder process. Parties are directed to limit their updates to the sufficiency of the process and not to address substantive issues discussed at the stakeholder meeting.

The updates will be held remotely via Webex. A link to view the updates will be posted to the Commission's website.

As established in previous procedural orders in this docket, following the stakeholder process, Duke is directed to file a proposed Carbon Plan by no later than May 16, 2022. Additional procedures to be employed following the filing of the Carbon Plan will be scheduled by subsequent orders of the Commission.

## IT IS, THEREFORE, ORDERED as follows:

- 1. That Duke and the Public Staff are directed to present updates on the January 25, 2022 Carbon Plan stakeholder meeting on Monday, February 7, 2022, at 10 a.m., or directly following Staff Conference;
- 2. That any intervenor in this docket that participates in the January 25, 2022 stakeholder meeting may file a request with the Commission to present an overview of the stakeholder process on or before Tuesday, February 1, 2022; and
- 3. All parties presenting an overview must provide the name, email, and phone number for each participant of the overview to ncucwebex@ncuc.net on or before Thursday, February 3, 2022.
