- 1. GreenCo is a non-profit corporation organized pursuant to Chapter 55A of the laws of the State of North Carolina, with its corporate headquarters located at 5234 Greens Dairy Road, Raleigh, North Carolina 27616.
- 2. GreenCo was organized on behalf of the following electric membership corporations ("EMCs"), each of which is organized under Chapter 117 of the North Carolina General Statutes as a non-profit electric membership corporation, is headquartered in North Carolina, and is actively engaged in the retail distribution and sale of electricity within North Carolina to its member-owners:

- 3. GreenCo was formed primarily for the purpose of assisting member EMCs fulfill some of the obligations arising from the enactment of Session Law 2007-397 ("Senate Bill 3"), including the Renewable Energy Portfolio Standards ("REPS") of that legislation. GreenCo is not a power supplier or a public utility. Currently, the three primary services which are provided by GreenCo include compliance planning and reporting, energy efficiency program development and management, and assistance in the development and monitoring of renewable energy activities and demonstration projects.
- 4. GreenCo and its member EMCs have a direct interest in the establishment of the tracking system which is the subject of this docket, as the purchase, sale and exchange of Renewable Energy Certificates ("RECs") will play a significant role in fulfilling the REPS and other obligations of the retail electric suppliers under Senate Bill 3. The interests of GreenCo and its member EMCs are not adequately represented by any other party, and GreenCo should not be consolidated with any party or group of parties.
