NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and respectfully moves the North Carolina Utilities Commission (Commission) for an extension of 12 days for the filing of proposed orders and/or briefs as set out in the Commission's Notice of Due Date for Proposed Orders and/or Briefs filed in this proceeding on October 25, 2021 and also for filing of an energy efficiency mechanism as contemplated in Paragraph 27 of the Stipulation of Settlement (Stipulation) filed in the herein dockets on October 15, 2021. In support of this motion, the Public Staff respectfully shows unto the Commission the following:

1. On October 15, 2021, Public Service Company of North Carolina, Inc. d/b/a Dominion Energy North Carolina (PSNC or the Company), the Public

Staff, Carolina Utility Customers Association, Inc. (CUCA), Evergreen Packaging, LLC (Evergreen) (collectively, the Stipulating Parties) filed a Stipulation in these dockets. In support of the Stipulation, the Stipulating Parties filed Settlement Exhibits.

- 2. The Public Staff and the Company have worked diligently on a joint proposed order but need additional time to finalize it. Further, it has recently come to the attention of the Public Staff and the Company that certain excess deferred income tax (EDIT) balances reflected in Settlement Exhibit K need to be corrected.
- 3. The Company and the Public Staff are working together to verify correct amounts and will need time to discuss any changes with the other Stipulating Parties and file an amendment to the Stipulation with the Commission.
- 4. To allow the parties in these proceedings adequate time to verify correct amounts and incorporate updated information into an amendment to the Stipulation, the Public Staff requests that the Commission grant an extension of 12 days, until December 6, 2021, for the parties to file an amendment to the Stipulation, and proposed orders and/or briefs in this proceeding.
- 5. On November 10, 2021, PSNC and the Public Staff filed a Joint Motion for Extension of Time to November 24, 2021, to file an agreed form of energy efficiency mechanism with the Commission as contemplated in Paragraph 27 of the Stipulation This extension request was granted by the Commission Order on November 19, 2021.
- 6. The Public Staff and PSNC continue to diligently work to finalize the energy efficiency mechanism but anticipate needing more time. The Public Staff

and the Company, therefore, request that they be given an additional extension of 12 days to file the mechanism.

7. The Public Staff has conferred with the other parties to these proceedings regarding these requests and has been informed that the parties do not object to the request for relief set forth herein.

WHEREFORE, for the reasons set forth above, the Public Staff respectfully requests that the Commission extend the time for filing the energy efficiency mechanism and proposed orders and/or briefs to December 6, 2021.
