NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and respectfully requests on behalf of itself and the North Carolina Justice Center (NCJC) and the Southern Alliance for Clean Energy (SACE), that the Commission extend by one day the time in which to file intervenor and rebuttal testimony in the above-captioned docket. In support of this motion, the Public Staff shows as follows:

1. On March 29, 2018, the Commission issued an Order Scheduling Hearing, Requiring Filing of Testimony, Establishing Discovery Guidelines and Requiring Public Notice in this docket setting a deadline for the filing of intervenor testimony of May 21, 2018, and for the filing of rebuttal testimony of May 31, 2018.

2. Due to the press of business and illness of witnesses, the Public Staff, NCJC, and SACE request an additional day in which to file intervenor testimony, with Duke Energy Carolinas, LLC, being allowing an additional day in which to file its rebuttal testimony.

3. Therefore, the Public Staff, NCJC, and SACE respectfully request that the Commission extend the deadline for the filing of intervenor and rebuttal testimony from May 21, 2018, to May 22, 2018, and from May 31, 2018, to June 1, 2018, respectively.
