**Re: Implementation by the North Carolina Utilities Commission (the Commission)  
of Executive Order No. 142 (Previously EO No. 124)**

Dear Governor Cooper:

This report covers activities related to EO 142 for the period beginning May 1, 2020, and ending May 31, 2020 (the Reporting Period). This report is the second for which the reporting period spans one month and builds upon the data collected for reports submitted on April 13, 20, and 27 and May 4 and 15. This report includes information provided by 367 Utility Service Providers,<sup>1</sup> more than half of all Utility Service Providers in North Carolina. Most of the state's large and mid-sized providers submitted reports and most of the providers that did not report serve smaller numbers of customers.

On May 12, 2020, the Attorney General's Office granted waiver of the reporting requirements for five "foreign" electric membership corporations.<sup>2</sup> These EMCs are headquartered outside of North Carolina, and their billing systems do not allow them to track North Carolina customers separately from their other customers. In requesting the waiver, these five EMCs committed to continue to abide by the requirements of EO 124 for disconnects, penalties, and repayments. Of the 367 Utility Service Providers that reported, 77 are electricity providers, eight are natural gas providers, and 282 are providers of water and/or wastewater services. Additionally, of those 367 Utility Service Providers that reported, 276 are governmental or quasi-governmental entities, 45 are investor-owned, and 46 are member-owned.

### Residential Accounts<sup>3</sup>

During the Reporting Period, an additional 458,634 residential customer accounts became eligible for disconnection due to non-payment but were not disconnected, which is an increase of 33,180 from the 425,454 accounts which were reported last month. This means that between April and May, 884,088 residential customer accounts have become eligible for disconnection across the state but have not been disconnected.

The Utility Service Providers report that 15,492 extended repayment plans were established for residential customers during the Reporting Period, an increase from the 14,638 reported in April. Additionally, 942 residential customers were reconnected during the Reporting Period (1,003 were reconnected in April). Finally, \$10,039,546 in late fees and penalties were not charged to residential customers during the Reporting Period. By comparison, \$10,709,687 of late fees and penalties were not charged in April.

### Non-Residential Accounts

During the Reporting Period, an additional 27,515 non-residential customer accounts became eligible for disconnection due to non-payment but were not disconnected, down slightly from the 28,470 reported in April. This means that between April and May, 55,985 non-residential customer accounts have become eligible for disconnection across the state but were not disconnected.

The Utility Service Providers report that 470 extended repayment plans were established for non-residential customers during the Reporting Period, up from 431 previously. Additionally, 90 non-residential customers were reconnected during the Reporting Period, up from 33 previously. Finally, \$1,287,231 in late fees and penalties were not charged to non-residential customers during the Reporting Period, down from \$1,393,425 in April.

### Utility Arrearage

With the transition to the monthly reporting obligation, the Commission requested that the Utility Service Providers provide information regarding their arrearages and past due accounts in order to better understand the financial impact of the COVID-19 crisis on Utility Service Providers and their customers. As this information was not specifically requested in EO 124 or 142, the Commission did not require Utility Service Providers to respond, and not all did.

As of May 31, Utility Service Providers report an aggregate of \$252,110,079 in residential and non-residential customer arrearages. Of this reported amount, approximately 60% is attributable to the three largest investor-owned electric utilities - Duke Energy Carolinas, Duke Energy Progress, and Dominion Energy.

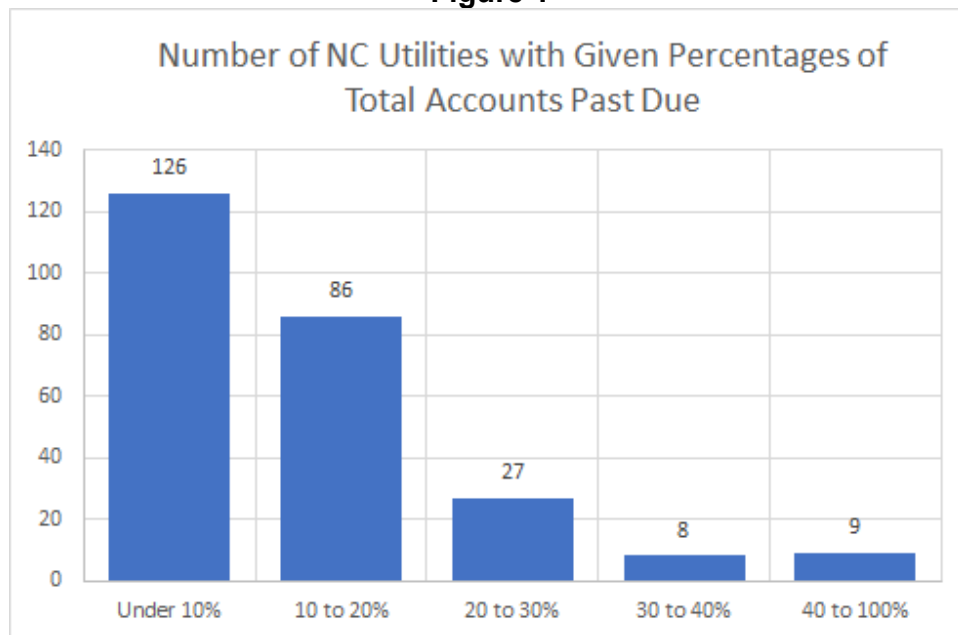

For the 235 Utility Service Providers that provided the number of past due residential accounts for both April and May, there were 29,892 fewer residential accounts past due in May than there were in April, but the total residential arrearages for those utilities went up by \$24,208,280.

The average percentage of customers with past due accounts for the 256 Utility Service Providers that reported this information was 13.7%. Forty-four utilities reported that over 20% of their customer accounts were past due and nine utilities reported that over 40% of their customer accounts were past due. A summary of the distribution of total accounts past due is provided in Figure 1.

Because some Utility Service Providers elected not to report information related to arrearages, the information reported herein represents partial, and not a complete, impact of the crisis on North Carolina's Utility Service Providers.

### Customer Notifications

Utility Service Providers took a variety of actions throughout the Reporting Period to inform their customers of the utility-related provisions of EO 142. Some examples of actions taken include:

- Notice posted at office
- Posted Executive Order and brief description on the Town's website
- Posting on Town's website and on Facebook; radio interview with local radio station; press release
- Put a notice on the door in the Town Hall
- Posted notice on the Town's website and the doors of the Town Hall; also put on bills
